<b>1. Incident Name:</b> Washington River Sodium Hydroxide, NaOH Spill	<b>2. Operational Period:</b> Date From: 1/12/2019 Time From: 10:00	Date To: 1/12/2019 Time To: 10:00
<b>3. Objective(s):</b> <ol style="list-style-type: none"> <li>1. Protect the health and safety of the public and responders.</li> <li>2. Protect sensitive areas to minimize impact to the environment, cultural, subsistence, and economic resources and property.</li> <li>3. Evaluate and improve strategies as necessary.</li> <li>4. Evaluate the chemical substance involved: State of material (solid, liquid, gas); Quantities involved; Number of victims; Signs or symptoms; Nature of exposure (inhalation, dermal, etc.); Length of exposure.</li> <li>5. Maintain capability for operations, develop plans, and implement as appropriate.</li> <li>6. Establish the framework for operations following the SMART model or a similar approach.</li> </ol>		
<b>4. Operational Period Command Emphasis:</b> <ol style="list-style-type: none"> <li>1. Review safety operations prior to conducting operations.</li> <li>2. For medical emergencies notify Command Post immediately.</li> <li>3. Paramedics located at the Command Post and at Staging.</li> <li>4. All personnel will wear proper PPE during operations.</li> <li>5. Review and comply with Standard Operational Procedures for Sodium Hydroxide, NaOH</li> </ol>		
<b>General Situational Awareness</b> <ol style="list-style-type: none"> <li>1. Weather conditions warrant special considerations for heat exposure potential.</li> <li>2. Take appropriate precaution.</li> <li>3. Any personnel working around or with the spill shall have appropriate certifications/training and provide certificates to Safety Officer prior to working.</li> </ol>

## ICS 202

### Incident Objectives

**Purpose.** The Incident Objectives (ICS 202) describes the basic incident strategy, incident objectives, command emphasis/priorities, and safety considerations for use during the next operational period.

**Preparation.** The ICS 202 is completed by the Planning Section following each Command and General Staff meeting conducted to prepare the Incident Action Plan (IAP). In case of a Unified Command, one Incident Commander (IC) may approve the ICS 202. If additional IC signatures are used, attach a blank page.

**Distribution.** The ICS 202 may be reproduced with the IAP and may be part of the IAP and given to all supervisory personnel at the Section, Branch, Division/Group, and Unit levels. All completed original forms must be given to the Documentation Unit.

#### Notes:

- The ICS 202 is part of the IAP and can be used as the opening or cover page.
- If additional pages are needed, use a blank ICS 202 and repaginate as needed.

Block Number	Block Title	Instructions
1	<b>Incident Name</b>	Enter the name assigned to the incident. If needed, an incident number can be added.
2	<b>Operational Period</b> <ul style="list-style-type: none"><li>• Date and Time From</li><li>• Date and Time To</li></ul>	Enter the start date (month/day/year) and time (using the 24-hour clock) and end date and time for the operational period to which the form applies.
3	<b>Objective(s)</b>	Enter clear, concise statements of the objectives for managing the response. Ideally, these objectives will be listed in priority order. These objectives are for the incident response for this operational period as well as for the duration of the incident. Include alternative and/or specific tactical objectives as applicable. Objectives should follow the SMART model or a similar approach: <u>Specific</u> – Is the wording precise and unambiguous? <u>Measurable</u> – How will achievements be measured? <u>Action-oriented</u> – Is an action verb used to describe expected accomplishments? <u>Realistic</u> – Is the outcome achievable with given available resources? <u>Time-sensitive</u> – What is the timeframe?
4	<b>Operational Period Command Emphasis</b>	Enter command emphasis for the operational period, which may include tactical priorities or a general weather forecast for the operational period. It may be a sequence of events or order of events to address. This is not a narrative on the objectives, but a discussion about where to place emphasis if there are needs to prioritize based on the Incident Commander's or Unified Command's direction. Examples: Be aware of falling debris, secondary explosions, etc.
	General Situational Awareness	General situational awareness may include a weather forecast, incident conditions, and/or a general safety message. If a safety message is included here, it should be reviewed by the Safety Officer to ensure it is in alignment with the Safety Message/Plan (ICS 208).
