ASSESSMENT 3: QUESTION

Written Presentation

You are employed as a cadet within an international company that processes dental insurance claims on behalf of an insurance company. Your responsibility is to process all submitted insurance claim, and once the claims are approved, you send the relevant dental office a cheque for payment.

Within a short period of time of commencing your role, you suspect several of the insurance claims may be fraudulent. You believe the only way to validate the accuracy of the claims is to obtain documentary evidence. You speak to your manager who provides you with the following excel documents to commence your investigation:

2. ch08_claims.csv
3. ch08_patients.csv

Question 1:

A key indication of whether a dental practice is legitimate is through its billing address. A real dental practice will need a physical address (that is, a street address) for clients to physically visit to obtain a dental service. Review the data provided and identify, if any, dental offices which are using a post office address.

Question 2:

A key indication of whether a dental practice is legitimate is through their business practice—each office should be submitting claims to various insurance companies. The company you work at is only one of many companies that processes insurance claims. Therefore the sequential numbers of the claims received by your office are important. For example, if the claims sent to you from a dentist are sequential (1, 2, 3 etc.) you can deduce that the dentist is only sending claims to you. Review the data provided and identify, if any, dental offices have submitted claims with sequential numbers.

Question 3:

Due to the limited nature of the need for dental work, it is unusual for a client to seek treatment for multiple cavities in a few months. Review the data provided and identify the number of cavities submitted by each patient. Use your judgment and assess whether any patients have claimed excess dental work (keep in mind, it is possible to have more than one cavity in a tooth).

Question 4:

A key indication of whether a dental practice is legitimate is through assessing the client's residential address and comparing this with their dental office's billing address. This is because, clients tend to travel locally to their dentist. Using geographic information, such as 'google maps', assess the distance each client travels to their dentist. Use your judgment and assess whether any patients have an unusually long trip to their dentist.

Written Presentation

Tasks:

1. Provide a written response for each of the four questions. In each of your responses, include an explanation of the steps you undertook to reach your findings **(24 marks)**.
2. Provide a summary that specifies the dentist/s you believe are submitting fraudulent claims. In preparing your summary, clearly specify the reasons to support your conclusions **(6 marks)**.

The submission should not exceed 2,000 words. The assessment must be submitted to Turnitin by **2PM Wednesday, 9th September 2020**.
