Affidavit in support of a criminal complaint

I, Muhammad Khan, being duly sworn, do hereby state and depose as follow:

Introduction

I am a special agent of a Fairfax county police. I am submitting this affidavit in support of a search warrant for Anwar Tsarni. He is currently working as a graduate teaching assistant at George Mason University. During our investigation we have found that Anwar Tsarni is being involved in terrorist activities. Our investigation shows that he was previously involved with the Boston Marathon bombers Dzhokhar Tsarnaev and Tamerlan Tsarnaev. Our intelligence report shows that he is currently working on an attack that will happen in U.S. and according to our intelligence report he is conducting all of his operation from a room # 512 of Engineering building of George Mason University Fairfax campus (4400 University Drive Fairfax, Virginia 22030).

Overview of an Investigation

Our special task force team and intelligence team spent day and night to collect evidence against Anwar Tsarni. It's been six months and we have enough evidence against Anwar to request a search warrant of his office for where he operates most of his terrorist tasks. We have seen him caring a DSLR around him in different part of Washington DC and have seen him taking photos of multiple places. Also, he bought two micro SD cards from his co-worker as we have surveillance video where we can clearly see him buying two SD cards. From a book shop on campus, has also bought some maps of Washington DC area, which we believe that he will be using them to mark located of his upcoming attack.

In addition, he has also bought a bundle of empty CDs/DVDs from a bookstore at GMU. He has some notes carried around with him all the time and also feel likes from his cloths that he is also carrying 9mm pistol sometimes when he goes out from his office, one night on the surveillance camera we saw him carrying something white powder in a plastic bag that we believe it could be cocaine.

From all the surveillance videos and wiretaps we have a probable cause of searching his office.
