

# Unit 1 Assignment: "To be or not to be...a fixture"

#### Overview:

For this assignment, you will locate a case from your state where the court decided that an item of personal property is either a fixture or personal property, and discuss the Court's reasoning for its conclusion.

#### Instructions:

The case you find must have at least one of the issues to be decided, whether some item is a fixture (*not* whether the property was improperly seized by the government, or another issue that has nothing to do with the item's classification). In a *thoughtful*, *substantive* response complete the following:

- First, define a fixture, then personal property, with proper citations for each definition, either from the case or your textbook.
- Next, name the case (i.e., in Town of Windsor v. Smith).
- Then, summarize the item(s) in dispute (the parties were disputing whether the ceiling fan located within the premises was a fixture).
- Discuss: The court (reasoned, determined, concluded) that because the (item) ... (Read your case and describe the tests from which the court based its decision. Those tests should be familiar to you from the assigned reading).
- Conclude with what the court determined (The court found that the ceiling fan was in fact...).
- Finally, provide the citation i.e., 19 Conn. 451 (2012).

### Requirements:

- Your paper should be at least one (1) but not more than two (2) pages in length, double-spaced, 12 pt. font, Times New Roman.
- All work should be written in proper Bluebook format.
- A link to the case is provided with the assignment.

Be sure to read the criteria by which your work will be evaluated before you write and again after you write.
